### ORDINANCE NO. 8

## AN ORDINANCE ALTERING BOUNDARIES OF IDYLLWILD COUNTY WATER DISTRICT

BE IT ORDAINED by the Board of Directors of the Idyllwild County Water District, Riverside County, California, as follows:

- 1. That a petition, duly acknowledged, and signed by a majority in number of the holders of title, or evidence of title, to a majority in acreage of the land described therein according to the last equalized assessment roll of the County of Riverside, together with a particular description of the land proposed to be annexed, was filed with the Secretary of said District on the 16th day of November, 1957, which petition prayed that said lands be added to the District in accordance with the provisions of the County Water District Act.
- 2. That the Secretary of said District duly set a date for the hearing of said petition and caused to be published in the Hemet News, a newspaper printed and published in the County of Riverside, there being no newspaper printed and published in the District, a notice stating the purpose of the petition, describing the lands to be added and motifying all persons interested of the hearing thereon to be held on Thursday, December 12, 1957, at the hour of 7:30 o'clock P.M. at the regular meeting place of the Board of Directors of said District, Fire Station, Idyll-wild, California, the affidavit of which publication has been presented to and is on file with this Board, and that said petition and said notice so published are in the form required by said Act.
- 3. That all acts and conditions and things required by law to be done precedent to the hearing of said petition by this Board have been done and have been performed in regular and in due form and in strict compliance with the provisions of the law authorizing the presentation of said petition.

- 4. That at the time and place fixed in said notice this Board proceeded to hear said petition, and all written objections thereto, No such objections were received, and upon the hearing of said petition, and after a full investigation and examination, this Board has found and declared and does hereby find and declare, that said petition complies with the requirements of the County Water District Act, and this Board does hereby find and declare the addition to the District of the lands proposed to be added as authorized by said Act and will be for the best interest of the District, and of the lands to be added.
- 5. That the boundaries of the Idyllwild County Water District shall be, and they are hereby, altered by adding thereto the hereinafter described territory, which territory is hereby annexed to said District, and the boundaries of which territory so annexed are situate in the County of Riverside, State of California, and are more particularly described in Exhibit "A" hereto attached and by reference incorporated herein.
- 6. This Ordinance shall be posted in three public places within the District.

#### ANNEXATION 1957-1

A parcel of land situated in the County of Riverside, state of California, being more particularly described by metes and bounds as follows;

Feginning at the northeast corner of the  $E_2^1$  of the SW- $\frac{1}{4}$  of Section 18, Township 5 South, Range 3 East, San Bernardino Base and Meridian, said northeast corner also being the northeast corner to Mount San Jacinto Golf Club Subdivision as shown on that certain map filed in Book 13, Pages 21 and 22 of Maps, Official Records of Riverside County, California; thence 30 feet west along the northerly line of said Subdivision to the true point of beginning; thence westerly along the northerly line of said Subdivision, said line also being a portion of the boundary of the Idyllwild County Water District, to the Northwest corner of the  $E_2^1$  of the SW- $\frac{1}{4}$  of Section 18; thence southerly along the westerly line of said Subdivision, said line also being a portion of the boundary of the Idyllwild County Water District, a distance of 264.0 feet; thence easterly a distance of 1286.1 feet to the westerly line of Pine Ave; thence 281.0 feet northerly along the westerly line of Pine Ave; thence 281.0 feet northerly along the westerly line of Pine Avenue to the true point of beginning.
