ORDINANCE NO. 13

AN ORDINANCE ALTERING BOUNDARIES OF IDYLLWILD COUNTY WATER DISTRICT

Ameration 1959-1 Kent

BE IT ORDAINED by the Board of Directors of the Idyllwild County Water District, Riverside County, California, as follows:

- 1. That a petition, duly acknowledged, and signed by all of the holders of title, or evidence of title, to all of the acreage of the land described therein according to the last equalized assessment roll of the County of Riverside, together with a particular description of the land proposed to be annexed, was filed with the Secretary of said District on the 6th day of February, 1959, which petition prayed that said lands be added to the District in accordance with the provisions of the County Water District Act.
- 2. That the Secretary of said District duly set a date for the hearing of said petition and caused to be published in the Hemet News, a newspaper printed and published in the County of Riverside, there being no newspaper printed and published in the District, a notice stating the purpose of the petition, describing the lands to be added and notifying all persons interested of the hearing thereon to be held on Wednesday, March 4, 1959, at the hour of 8:00 o'clock P.M. at the regular meeting place of the Board of Directors of said District, Idyllwild County Water District Office Building, Pinecrest Avenue and Idyllwild Banning Road, Idyllwild, California, the affidavit of which publication has been presented to and is on file with this Board, and that said petition and said notice so published are in the form required by said Act.
- 3. That all acts and conditions and things required by law to be done precedent to the hearing of said petition by this Board have been done and have been performed in regular and in due form and in strict compliance with the provisions of the law authorizing the presentation of said petition.

- 4. That at the time and place fixed in said notice this Board proceeded to hear said petition, and all written objections thereto, Moderate such objections were received, and upon the hearing of said petition, and after a full investigation and examination, this Board has found and declared and does hereby find and declare, that said petition complies with the requirements of the County Water District Act, and this Board does hereby find and declare the addition to the District of the lands proposed to be added as authorized by said Act and will be for the best interest of the District, and of the lands to be added.
- 5. That the boundaries of the Idyllwild County Water District shall be, and they are hereby, altered by adding thereto the hereinafter described territory, which territory is hereby annexed to said District, and the boundaries of which territory so annexed are situate in the County of Riverside, State of California, and are more particularly described in Exhibit "A" hereto attached and by reference incorporated herein.
- 6. This Ordinance shall be posted in three public places within the District.

PROPERTY PROPOSED TO BE ANNEXED TO IDYLLWILD COUNTY WATER DISTRICT

ANNEXATION NO. 1959-1

That portion of Government Lot 4 of Fractional Section 18, Township 5 South, Range 3 East, San Bernardino Base and Meridian, described as follows:

Beginning at the Northwest corner of said Government Lot 4; thence North 88° 29' East on the Northerly line of said Lot, 1352.10 feet to the Northeast corner thereof; thence South 0° 46' East, on the Easterly line of said Government Lot 4, a distance of 490.41 feet; thence South 24° 49' 45" West, a distance of 462.90 feet; thence South 73° 37' West, 568.97 feet to a point on the Easterly line of that certain parcel of land conveyed to the County of Riverside by deed filed for record July 13, 1948 as Instrument No. 1686, at a point which bears South 0° 26' East, 146.00 feet from the Northeast corner thereof; thence North 0° 26' West on the Easterly line of said parcel so conveyed to the County of Riverside, 146.00 feet to the Northeast corner thereof; thence South 88° 29' West on the Northerly line of said parcel so conveyed to the County of Riverside, 610.27 feet to a point in the Westerly line of said Government Lot 4; thence North 0° 26' West on the Westerly line of said Government Lot 4, a distance of 905.36 feet to the point of beginning.
